



## Nevada Volunteers GY2019 – 2020 Funding Opportunity Timeline

**All new applicants must contact Hawley Harrigan, [hawley@nevadavolunteers.org](mailto:hawley@nevadavolunteers.org) or (775) 825-1900, directly before beginning an application. It is Nevada Volunteers' goal to partner with organizations interested in hosting an AmeriCorps program to create strong programs for the state of Nevada. This partnership will require frequent, open communication.**

### Competitive Applications

Competitive applicants are generally long-standing AmeriCorps programs in the state of Nevada. Nevada Volunteers will provide supports to organizations looking to apply for competitive funding when possible.

- Notice of Federal Funding Opportunity released by **October 1, 2018** (unless delayed by CNCS)
- Draft applications due in eGrants by Thursday, **November 15, 2018** 2:00 pm PST
- Final application due in eGrants by Thursday, **January 17, 2019** 2:00 pm PST
- Clarification will take place at the discretion of CNCS
- Applicants will be notified by **May 20, 2019** of funding decision (unless delayed by CNCS)

### Operational Formula Applications

Formula funding is awarded at Nevada Volunteers' discretion to nonprofits, institutions of higher education, and government agencies who are interested in hosting an AmeriCorps program in the state of Nevada. Nevada Volunteers recommends pursuing a planning grant prior to applying for operational funding but, if your organization has strong systems to manage federal funds in place, will consider new programs for operational formula funding.

- Notice of Federal Funding Opportunity released Monday, **January 21, 2019**
- Informational Webinar, Thursday January 24, 10:00 am – 11:00 am (highly recommended for new applicants)
- Letter of Intent due Thursday, **March 7, 2019** (not required for continuation applicants)
- Training and Technical assistance webinars will be provided to assist with application development during March and April
- Final application due in eGrants **Thursday, April 25, 2019**
- Clarification period will be May 23- 31, 2019
- Applicants will be notified by Wednesday, **July 17, 2019** of funding decision (unless delayed by CNCS)

### Planning Grants

New applicants are encouraged to apply for a planning grant to receive funding of up to \$75,000 to develop a strong AmeriCorps programs. Planning grants are awarded throughout the year at Nevada Volunteers discretion depending on funding availability.
